An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 22, 2018 through the Interactive Zoning Information System (IZIS).

Application of Yasmine Sikder, pursuant to 11 DCMR Subtitle X, Chapter 10, for area variances from the lot dimension requirements of Subtitle D § 302.1 and the side yard requirements of Subtitle D § 307.1, to construct a new principal dwelling unit in the R-2 Zone at premises 308 62nd Street N.E. (Square 5267, Lot 44).

You will need to create a username and password if you have not done so already.
