The issues and concerns of the ANC about the appeal, petition, or application as related to the standards of the Zoning Regulations against which the appeal, petition, or application must be judged (a separate sheet of paper may be used):

There were no negative impacted issues stated by the adjoining neighbors, nor from the Stronghold Civic Association.

On July 9, 2018, at the SCA regularly scheduled public meeting, the Applicant requests support of a special exception relief for a Child Care Development Home to expand from 9 to 12 students. The license is for children ages 6 weeks to 12 years old. The business has had yearly visits by Office of the State Superintendent of Education and no issues have been found. A resident said he visited the facility and found it nice and good for the neighborhood; the SCA president knows neighbors whose children attend the Child Care Development Home. She stated that the neighbors are pleased.

A vote was requested. Motion Passed.

The recommendation, if any, of the ANC as to the disposition of the appeal, petition, or application (a separate sheet of paper may be used):

This business has been found to comply with background checks and trainings requirements; no citations or disciplinary history. There seems to be a 30 child waiting list for attendees.

On September 18th, 2018, at a regularly scheduled public meeting, ANC 5E recommends that the Board grant approval of the special exception relief requested to expand from 9 students to 12 students for the Child Care Development Home.
