An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on July 7, 2018 through the Interactive Zoning Information System (IZIS).

Application of Peter and Stephanie Eicher, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exception under Subtitle D § 5201 from the lot occupancy requirements of Subtitle D § 304.1, the rear yard requirements of Subtitle D § 306.2, and the pervious surface requirements of Subtitle D § 308.3, to construct a three-story rear addition and deck in the R-3 Zone at premises 600 H Street S.W. (Square 468, Lot 67).
