An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>August 23</u>, <u>2018</u> through the Interactive Zoning Information System (IZIS).

(Square 926, Lots 809 and 810).
