Application of MDP 526 8th Street LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, and pursuant to Subtitle X, Chapter 10, for a variance from the loading berth requirements of Subtitle C § 901, to construct a new three-story commercial building in the MU-25 Zone at premises 526-528 8th Street S.E. (Square 926, Lots 809 and 810).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
