An individual, organization, or ANC is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations) regarding property within your ANC's boundaries. **Appeal of ANC 3C**, pursuant to 11 DCMR Subtitle Y § 302, from the decision made on August 7, 2018 by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to approve a modification to the plans approved by BZA Order No. 19450, to construct a short-term family housing center in the RA-1 Zone at premises 3320 Idaho Avenue N.W. (Square 1818, Lot 849).

- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.

## HOW TO PARTICIPATE IN THE CASE

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and Board gives "great weight" to its written report.
