On March 27, 2025, the District of Columbia Public Space Committee, PSC Approved with Conditions your application for Projections: Other (Exception – Not to Building Code) in public space:

This is for 1724 North Capitol Street NW, right? I've been discussing this with Janet Steadman. She has been presenting herself as the owner. I haven't spoken to Mrs. Lateef.

This property is not subject to CFA review, but it is subject to HPRB review.

Our position at Historic is that DDOT should go first and determine if the property owner has permission to put a shed in public space. Sheds in public space are not a historic condition and are very uncommon, but we understand that the lack of alley access might make this property an exception to DDOT's rules. We've asked Ms. Steadman about putting the trash use in the existing CMU projection rather than in a new shed, but she says the kitchen's health code required refrigeration units are already in that projection.

If DDOT (et al) approves the owner's use of a shed in this location, the owner will need a building permit for the shed and in that application Historic will take up the issue of what the shed must look like so that it is sufficiently compatible with the historic district. We might condition our approval on some sort of screening device or material change. But there's no reason for Historic to take up the question of appearance before DDOT settles the question of use. If DDOT denies the use, then Historic won't have anything to review.

The shed they recently installed for their trash is one of the best I've seen a restaurant have. When they first put it up, there were some rats still trying to break into it but they kept making adjustments to keep them out. In fact I haven't seen any rats outside at the shed in awhile. The only ones I still see are next door to the restaurant at 9 Randolph Place NW because that person must not be keeping his place as tidy because the rats are always coming in and out of his yard. His next door neighbor at 11 Randolph Place says the same - she has to keep her house extra clean because this guy has junk all over and is making it hard for her to keep them away.

The alleyway behind my house is also flooded with rodents because just a few people don't put their trash in the bins securely and the rats have a feast. The neighbors I talk to all agree that the restaurant does a way better job than most of the neighborhood ensuring they don't attract any rodents.

I'm not sure what code or whatever the restaurant might not be going by but that's the last place on my block that I would expect to see rodents. The employees all do a really good job of making sure the shed stays clean with cans that shut properly. I wish more places in DC would be as careful as Jam Doung.
