Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on Wednesday, March 27, 2019 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of AMM2 Investments LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the new residential development requirements of Subtitle U § 421.1 and under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, to construct a new eight-unit apartment house in the RA-1 Zone at premises 413 60th Street N.E. (Square 5261, Lot 803).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.


