Dear ANC Chair:

An Applicant within 200 feet of your ANC boundary is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, December 19, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 2020 M Street LLC and 2030 M Street LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C §§ 1304.2 and 1312 from the roof-mounted antenna setback and height requirements of Subtitle C § 1304.1(a) and (b), to locate three antennas on the roof of a to-be-constructed 11-story office building in the D-5 Zone at premises 2050 M Street N.W. (Square 100, Lot 122).

Pursuant to Subtitle Y § 402.1, notice of public hearing is provided to ANCs within 200 feet of the property involved in the application; however, an ANC within 200 feet of the property is not an “affected ANC” unless the subject property is located on a street that serves as a boundary line between two ANCs.
