**Application of Coloma River Capital,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, under Subtitle G § 1200 from the closed court requirements of Subtitle G § 202.1, and under Subtitle G § 1201 from the rear yard requirements of Subtitle G § 405.2, to construct a new 46-unit apartment house with ground floor retail in the MU-4 Zone at premises 71 Kennedy Street N.W. and 5505 1st Street N.W. (Square 3389, Lots 822 and 817).
