An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on October 20, 2018 through the Interactive Zoning Information System (IZIS).

Application of 5935 Colorado Ave Associates LLC, pursuant to 11 DCMR Subtitle X, Chapter 10, for area variances from the floor area ratio requirements of Subtitle F § 302.1, from the lot occupancy requirements of Subtitle F § 304.1, from the side yard requirements of Subtitle F § 306.1, and from the penthouse setback requirements of Subtitle C § 1502.1, to convert an existing detached principal dwelling unit to a five-unit apartment house in the RA-1 Zone at premises 5835 Colorado Avenue N.W. (Square 2937, Lot 832).
