Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, February 6, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 5935 Colorado Ave Associates LLC, pursuant to 11 DCMR Subtitle X, Chapter 10, for area variances from the floor area ratio requirements of Subtitle F § 302.1, from the lot occupancy requirements of Subtitle F § 304.1, from the side yard requirements of Subtitle F § 306.1, and from the penthouse setback requirements of Subtitle C § 1502.1, to convert an existing detached principal dwelling unit to a five-unit apartment house in the RA-1 Zone at premises 5835 Colorado Avenue N.W. (Square 2937, Lot 832).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

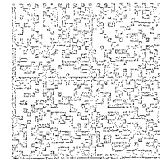

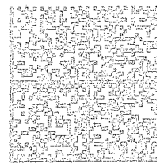

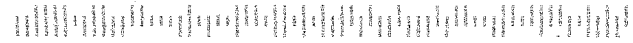
