An individual, organization, or ANC is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations) regarding property within your ANC's boundaries. This appeal was filed on <u>November 21, 2018</u> through the Interactive Zoning Information System (IZIS).

**Appeal of Cyrus Frelinghuysen, et al.,** pursuant to 11 DCMR Subtitle Y § 302, from the decision made on June 5, 2018 by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to issue building permits B1808453, B1812270, B1812271 and excavation permits EX1900001, and EX1900002, to construct three new detached principal dwelling units in the R-8 Zone at premises 3113 Albemarle Street N.W. (Square 2041, Lots 24, 25, and 26).

- The search results should produce the case on the right. Click "View Details".
- Click "View Full Log".
- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and Board gives "great weight" to its written report.
