Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, March 27, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Nation's Mosque, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E §§ 205.5 and 5201 from the rear addition requirements of Subtitle E § 205.4, and under Subtitle C § 1504 from penthouse enclosure requirements of Subtitle C § 1500.6 and the penthouse setback requirements of Subtitle C §§ 1502.1(b) and 1502.1(c)(2)(A), to construct an addition to the existing place of worship in the RF-1 Zone at premises 1519 4th Street N.W. (Square 521, Lot 829).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

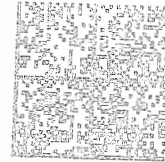
