An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on January 10, 2019 through the Interactive Zoning Information System (IZIS).

(Square 1019S, Lots 37 and 38).
