An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on January 10, 2019 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, April 3, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Spectrum Management**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle G §§ 708.1 and 1201 from the rear yard requirements of Subtitle G § 705.3, to construct a second-story addition on an existing one-story commercial use building in the MU-25 Zone at premises 1225-1227 Pennsylvania Avenue S.E. (Square 1019S, Lots 37 and 38).
