Re: BZA Case No. 19960 Applicant's Response to ANC5C's March 12 2019 Filing and Applicant's Updated Community Outreach Efforts

Chairperson Hill and Honorable Members of the Board:

On behalf of the Applicant, MCF 1400 Montana, LLC and MCFI Limited Partnership (collectively the "Applicant"), we submit the following response to the ANC's March 12, 2019 filing and an updated statement regarding Applicant's community outreach efforts.

Response to ANC 5C06 Commissioner's March 12 2019 Filing

We have reviewed the statements made by the ANC 5C06 Single Member District ("SMD") Commissioner at BZA Exhibit No. 38¹ and the following is our response.

Contrary to the SMD Commissioner's statement in her March 12th filing (BZA Exhibit No. 38) that the Applicant said the March 23rd SMD meeting "did not work for them," the Applicant has always been willing to work with the SMD Commissioner and to attend a SMD meeting. The Applicant originally requested to be put on the ANC agenda for the February ANC Meeting. However, the SMD Commissioner told the Applicant that a community meeting would need to be held before the SMD Commissioner would allow the Applicant to present at an ANC meeting. Accordingly, the Applicant sent the SMD Commissioner an email on February 25th, attached at **Exhibit A**, proposing a date and time for a community meeting. The Applicant followed up with the SMD Commissioner via email on March 6th, attached at **Exhibit B**, confirming their willingness to attend an SMD meeting on March 12th, Applicant received an email from the SMD Commissioner notifying the Applicant that they would not be able to present at the March 20th ANC meeting because of "failure to come to SMD meeting," attached hereto at **Exhibit C**. ¹We note that the Applicant was not served with the SMD's March 12, 2019 filing as required by the Zoning Regulations under Subtitle Y §§ 403.6 and 407.3. As this filing is in response to the ANC's March 12th filing, we do not believe that the Board is required to grant relief under Subtitle Y § 101.9. However, if the Board deems such waiver is needed, we believe this filing satisfies the standard.

expressed in their email to the SMD Commissioner on March 15th, attached at <u>Exhibit D</u>, Applicant continues to be willing to attend an SMD meeting on March 23rd, 2019.

Applicant's Updated Community Outreach Efforts

We take this opportunity to update the Board regarding the Applicant's March 14, 2019 community meeting. The Applicant flyered the community and around 20-25 people attended the meeting. The Applicant presented their plans for a 108-unit apartment building at 1400 Montana Avenue NE (the "Project") to the community last night. There was an open dialogue about the relief requested and the Project's current and future impacts on the neighborhood, including sidewalk improvements, traffic circulation, parking, and stormwater management. The Applicant pledged to work further with the community to bring the community's traffic and parking concerns to DDOT.

We thank the Board for allowing us to clarify the record and look forward to attending the April 3^{rd} Hearing.
