Chairperson Hill and Honorable Members of the Board:

On behalf of the Applicant, MCF 1400 Montana, LLC and MCFI Limited Partnership (collectively the "Applicant"), below is an update to the expert witness list and an update on the Applicant's community outreach efforts. Also, please find enclosed a land use report prepared by Stephen Varga, Director of Planning Services at Cozen O'Connor, at **Exhibit A**, and an updated landscape plan showing more street trees and trees around the parking court based on Applicant's most recent conversations with the Ward 5 arborist and additional GAR studies, attached at **Exhibit B**. ## **Applicant's Updated Community Outreach Efforts**

At the hearing on April 3, 2019, the Board heard the ANC's request for postponement as a preliminary matter and subsequently granted the ANC's request with the understanding that the Applicant would be put on the agenda for the ANC meeting scheduled for April 17, 2019, and that prior to that meeting, the Applicant would be permitted to present at a SMD meeting. At the close of the hearing, Commissioner Williams told the Applicant that they could present at the SMD meeting scheduled for 5 p.m., April 10, 2019 at the Brentwood Recreation Center. The Applicant
