#### **REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING**

An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>February 6</u>, <u>2019</u> through the Interactive Zoning Information System (IZIS).
