Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, May 22, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 1128 6th Street LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1, and under Subtitle F § 5201 from the lot occupancy requirements of F § 304.1 to construct a three-story addition, a rear penthouse addition, and to convert a principal dwelling into a six-unit apartment building in the RA-2 Zone at premises 1128 Sixth Street N.W. (Square 449, Lot 40).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
