#### REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 15, 2019 through the Interactive Zoning Information System (IZIS).

**Application of Matthew Oppenheim**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 304.1, the minimum rear yard setback requirements of Subtitle E § 306.1, and from the nonconforming structure requirements of Subtitle C § 202.2, to enclose an existing second-story rear porch, and to convert an existing flat to a semi-detached principal dwelling unit in the RF-1 Zone at premises 1005 P Street N.W. (Square 337, Lot 30).
