Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Matthew Oppenheim**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 304.1, the minimum rear yard setback requirements of Subtitle E § 306.1, and from the nonconforming structure requirements of Subtitle C § 202.2, to enclose an existing second-story rear porch, and to convert an existing flat to a semi-detached principal dwelling unit in the RF-1 Zone at premises 1005 P Street N.W. (Square 337, Lot 30).

## WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
