Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday**, **July 10**, **2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Charles and Kristi Cooper,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the use requirements of Subtitle U § 301.1(e), under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 304.1, and under Subtitle E § 5007 from the accessory building lot occupancy requirements of Subtitle E § 5003.1, to construct an accessory structure with a garage and second-story dwelling unit to an existing attached principal dwelling unit in the RF-1 Zone at premises 221 10th Street S.E. (Square 0944, Lot 0035).

# WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
