Application No. 20049 of Clementine Thomas and Sasaun Vasfi, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D §§ 5201, 5202 and 5205 from the rear yard setback requirements of Subtitle D § 1306.1, to construct a rear addition to an existing, detached principal dwelling in the R-21 Zone at premises 5011 Garfield Street, N.W. (Square 1426, Lot 864).

SUMMARY ORDER

<u>Relief Requested</u>. The zoning relief requested in this case was self-certified, pursuant to 11 DCMR Subtitle Y § 300.6. (Exhibit 11 (Revised); Exhibit 3 (Original).)

<u>Expedited Review</u>. Pursuant to 11 DCMR Subtitle Y § 401, this application was tentatively placed on the Board of Zoning Adjustment (the "Board" or "BZA") expedited review calendar for decision as a result of the applicant's waiver of its right to a hearing. No objections to expedited review consideration were made by any person or entity entitled to do under Subtitle Y §§ 401.7 and 401.8.

<u>Notice of the Application and Public Meeting</u>. The Board referred the application to the appropriate agencies and provided proper and timely notice of the public meeting in accordance with Subtitle Y § 402.1.

<u>Parties</u>. The parties to this case were the Applicant and Advisory Neighborhood Commission ("ANC") 3D.

<u>ANC Report.</u> The ANC's report indicated that at a regularly scheduled, properly noticed public meeting on July 10, 2019, at which a quorum was present, the ANC voted 6-0-0 to support the application. (Exhibits 30 and 34.)

<u>OP Report</u>. The Office of Planning submitted a report, dated July 19, 2019, recommending approval of the application. (Exhibits 31 and 32.)

<u>DDOT Report</u>. The District Department of Transportation submitted a report, dated July 8, 2019, indicating that it had no objection to the application. (Exhibit 28.)

<u>Persons in Support</u>. The Board received three letters from neighbors in support of the application. (Exhibits 38-40.)

Special Exception Relief

The Applicant seeks relief under Subtitle X § 901.2, for a special exception under Subtitle D §§ 5201, 5202 and 5205 from the rear yard setback requirements of Subtitle D § 1306.1, to construct a rear addition to an existing, detached principal dwelling in the R-21 Zone.

Based upon the record before the Board, and having given great weight to the appropriate reports and recommendations filed in this case, the Board concludes that the Applicant has met the burden of proof that the requested relief can be granted as being in harmony with the general purpose and intent of the Zoning Regulations and Map and that granting the requested relief will not tend to affect adversely the use of neighboring property in accordance with the Zoning Regulations and Map. The Board further concludes that, pursuant to Subtitle X § 901.2(c), any other specified conditions for special exception relief have been met.

Pursuant to 11 DCMR Subtitle Y § 604.3, the order of the Board may be in summary form and need not be accompanied by findings of fact and conclusions of law where granting an application when there was no party in opposition.

It is therefore **ORDERED** that this application is hereby **GRANTED AND**, **PURSUANT TO SUBTITLE Y § 604.10**, **SUBJECT TO THE APPROVED PLANS**¹ **AT EXHIBIT 5**.

PURSUANT TO SUBTITLE Y § 703.14, NO OTHER ACTION, INCLUDING THE FILING OR GRANTING OF AN APPLICATION FOR A MODIFICATION PURSUANT TO SUBTITLE Y §§ 703 OR 704, SHALL TOLL OR EXTEND THE TIME PERIOD.

PURSUANT TO 11 DCMR SUBTITLE Y § 604, APPROVAL OF AN APPLICATION SHALL INCLUDE APPROVAL OF THE PLANS SUBMITTED WITH THE APPLICATION FOR THE CONSTRUCTION OF A BUILDING OR STRUCTURE (OR ADDITION THERETO) OR THE RENOVATION OR ALTERATION OF AN EXISTING BUILDING OR STRUCTURE. AN APPLICANT SHALL CARRY OUT THE CONSTRUCTION, RENOVATION, OR ALTERATION ONLY IN ACCORDANCE WITH THE PLANS APPROVED BY THE BOARD AS THE SAME MAY BE AMENDED AND/OR MODIFIED FROM TIME TO TIME BY THE BOARD OF ZONING ADJUSTMENT.
