

Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Wednesday</u>, <u>July 17</u>, <u>2019 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Peter Roushdy and Kelly Franklin,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the lot occupancy requirements of Subtitle D § 304.1 to construct a rear deck addition to an existing, semi-detached principal dwelling unit in the R-3 Zone at premises 3764 Benton Street N.W. (Square 1301, Lot 672).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

#### HOW TO FAMILIARIZE YOURSELF WITH THE CASE
