**Application of Oxbridge Development QOZB at Fourth Street NE LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions from the retaining wall requirements of Subtitle C § 1401.7, under the inclusionary zoning provisions of Subtitle C § 1001.2(e)(3), and from the lot width requirements of Subtitle E § 201.1, to raze an existing detached principal dwelling unit, and subdivide the lot to construct three new, attached flats in the RF-1 Zone at premises 2637 4th Street N.E. (Square 3634, Lot 803).
