An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 3, 2019 through the Interactive Zoning Information System (IZIS).

Application of Studio Acting Conservatory on behalf of 3423 Holmead Place LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the use provisions of Subtitle U § 320.1(a) and Subtitle U § 203.1(l), to permit a private school use in an existing building in the RF-1 Zone at premises 3423 Holmead Place N.W. (Square 2834, Lot 63).
