Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, July 31, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of NW DC Property LLC, pursuant to 11 DCMR Subtitle X, Chapter 10, for area variances from the accessory use requirements of Subtitle U § 410.1(b), the lot occupancy requirements of Subtitle F § 604.1, and from the rear yard requirements of Subtitle F § 605.1, to enclose outdoor courtyard space and to construct a new, attached accessory structure to an existing hotel building in the RA-10 Zone at premises 1515 Rhode Island Avenue, N.W. (Square 195, Lot 149).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

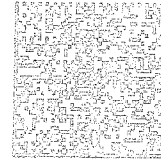
