### **REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING**

An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 4, 2019 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday, July</u> <u>31, 2019 at 9:30 am</u>, at the Jerrily R. **Application of Solid Properties LLC,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the new residential development requirements of Subtitle U § 421.1, to raze the existing swimming pool and accessory structure, and to construct a new, three-story 30-unit residential building in the RA-1 Zone at premises 130-134 Ivanhoe Street S.W. (Square 6271, Lot 32).

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and the Board gives "great weight" to its written report.
