An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 4, 2019 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday, July</u> <u>31, 2019 at 9:30 am</u>, at the Jerrily R. **Application of Solid Properties LLC,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the new residential development requirements of Subtitle U § 421.1, to raze the existing swimming pool and accessory structure, and to construct a new, three-story 30-unit residential building in the RA-1 Zone at premises 130-134 Ivanhoe Street S.W. (Square 6271, Lot 32).
