Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on Wednesday, September 11, 2019 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Zeta Phi Beta Sorority, Inc., pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the use provisions of Subtitle U § 320.1(a) and pursuant to Subtitle X, Chapter 10, for an area variance from the residential use requirements of Subtitle U § 203.1(n)(2), to permit a non-profit use in an existing, semi-detached principal dwelling unit in the RF-2 Zone at premises 1461 S Street, N.W. (Square 206, Lot 25).

## WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

## HOW TO FAMILIARIZE YOURSELF WITH THE CASE

The Board expects the ANC to review the case and submit a written report of its position on the Application prior to the BZA hearing.
