Application of Chad Clark, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the rear addition requirements of Subtitle D § 1206.3, to construct a three story rear addition to an existing, attached principal dwelling unit in the R-20 Zone at premises 1614 34th St N.W. (Square 1277, Lot 204).
