Application of Grand Realty LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the under the residential conversion requirements of Subtitle U § 320.2, pursuant to Subtitle § U § 301.1 (e) from the use requirements of Subtitle U § 301.1 (c)(1) and pursuant to Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 5003.1, to convert the existing detached principal dwelling into two principal dwelling units and to construct a second-story addition to an existing accessory structure to be used as a third principal dwelling unit in the RF-1 Zone at premises 1117 Morse Street, N.E. (Square 4070, Lot 136).

 - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
