The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for **Wednesday, December 4, 2019 beginning at 9:30 a.m.**, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of Susanna Chu and Ariel David Adesnik, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle D § 5201 from the side yard requirements of Subtitle D § 206.2 and from the rear yard requirements of Subtitle D § 306.1, to construct a one-story rear addition and a porch side addition to an existing detached principal dwelling unit in the R-1-B Zone at premises 4600 45th Street N.W. (Square 1569, Lot 1).

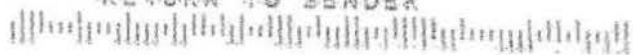

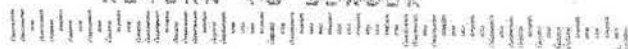
