The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for **Wednesday, January 15, 2020 beginning at 9:30 a.m.**, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of M Street Five, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the penthouse use provisions of Subtitle C § 1500.3(c), to construct a roof deck for a bar and restaurant use above an existing attached building in the MU-4 Zone at premises 3219-3221 M Street N.W. (Square 1207, Lot 114).

PLEASE NOTE REGARDING THE HEARING SCHEDULE:

There is the possibility this case may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled hearing date noted above. Participants may also visit <https://dcoz.dc.gov/onlineServices/webcast> to listen to the live broadcast of the hearing starting at 9:30 a.m. to hear the case line-up and may listen periodically throughout the hearing to see which case the Board is hearing at any point in time.

An Applicant within 200 feet of your property is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia require providing notice of the public hearing at which the Applicant is scheduled to appear before the Board to present their case. HOW TO FAMILIARIZE YOURSELF WITH THE CASE

A. Attend the Advisory Neighborhood Commission (ANC) Meeting

B. Read Documents in the Record

To review documents in the case, follow these steps:

- 1) Visit the Interactive Zoning Information System (IZIS) website at <https://dcoz.dc.gov/CaseRecord>.
- 2) Enter the BZA application number indicated above and click the search button.
- 3) The search results should produce the case on the right. Click "View Details".
- 4) Click "View Full Log".
- 5) This list comprises the full record in the case. Simply click "View" and it will open a PDF document in a separate window.

C. Speak with the Applicant/Applicant's Agent Directly

HOW TO PARTICIPATE IN THE CASE

You have the option of participating in the case through one or more of the options below:

A. Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition **before** the hearing.

- Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment by email to bzasubmissions@dc.gov
- **Electronic submissions sent after 9:00 A.M. on the morning of the hearing will not be accepted** into the record. Hard copy documents may be submitted to the case record by delivering in person at the time of the hearing when the case has been called by the Secretary.

B. Attend the hearing and provide oral testimony as a "person in support" or "person in opposition" at the hearing.

C. Apply for Party Status for more in depth involvement in the case.

- Upload a Party Status application (Form 140) to the case record in IZIS or send to bzasubmissions@dc.gov
- Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the originally scheduled hearing date set forth in this letter.
