The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for <u>Wednesday, February 12, 2020 beginning at 9:30 a.m.</u>, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001:

**Application of Sonia Ahmed and Farzaam Esmaeilian,** pursuant to 11 DCMR Subtitle X, Chapters 9, for a special exception under Subtitle D § 5201 from the rear yard requirements of Subtitle D § 306.2, and pursuant to Subtitle X, Chapter 10, for a variance from the lot occupancy requirements of Subtitle D § 304.1, to replace the rear deck addition to an existing attached principal dwelling unit in the R-3 Zone at premises 220 Ascot Place N.E. (Square 3557, Lot 69).

  - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
