Good Afternoon Everyone:

The Commissioners of Advisory Neighborhood Commission 5E (ANC5E) held a virtual conference this afternoon to discuss whether to continue with plans to hold our regular monthly public meeting on this coming Tuesday, March 17, 2020. By consensus we decided, in the best interests of the public, to CANCEL this month's meeting. While we were not mandated to cancel our meeting by the Mayor having declared a state of emergency in the District of Columbia, we came to the understanding that the benefits of going forward at this time are outweighed by the risk of exposure of our elderly, immune challenged and any other vulnerable community members to the coronavirus, COVID-19. All matters scheduled to be considered at our March meeting, including the introduction and initiation of the members of our new Zoning and Alcohol Licensing Advisory Committees, will be rescheduled for April, unless we hear from the presenters that they do not wish to present in April.

On behalf of ANC5E, I apologize for any inconvenience this late change of plans may cause but, for the greater good, we have concluded that canceling Tuesday's meeting is the prudent thing to do.
