REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on January 23, 2020 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on Wednesday, April 1, 2020 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of IDI Water Street, L.C., pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle C § 710.3 from the parking lot location requirements of Subtitle C § 710.2 (a), and pursuant to Subtitle X, Chapter 10, for variances from the driveway width requirement of Subtitle C § 711.6 (a), from the minimum dimensions for full-sized parking spaces and aisles of C § 712.5, and from the minimum dimensions for compact parking spaces and aisles of C § 712.6, to construct a 7-story residential building in the MU-13 Zone at premises 3401-3403 Water Street N.W. (Square 1183, Lot 813).
