**Application of 3400 Connecticut Partners LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, to construct a mixed use retail/apartments development in the NC-3 Zone at premises 3400 Connecticut Avenue, N.W. (Square 2069, Lots 817-821).
