Application of Charles and Dara Mooney, pursuant to 11 DCMR Subtitle Chapter 9, for a special exception under Subtitle E § 5201, from the lot dimension requirements of Subtitle E § 201.7, to convert the basement into a new fifth apartment unit in the existing apartment house in the RF-1 Zone at premises 1350 Queen Street, N.E. (Square 4076W, Lots 57 and 58).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant within 200 feet of your property is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. 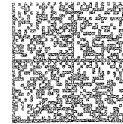

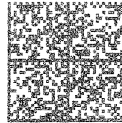
