TO WHOM IT MAY CONCERN:

The following Board of Zoning Adjustment (BZA) application has been rescheduled for the Virtual Public Hearing session on **Wednesday, February 24, 2021**, beginning at **9:30 a.m.** See page two for more details about accessing and participating in the virtual hearing via Webex and telephone.

Application of Charles and Dara Mooney, as amended, pursuant to 11 DCMR Subtitle X Chapter 10, for an area variance from the lot dimension requirements of Subtitle E § 201.7, to convert the basement into a new fifth apartment unit in the existing apartment house in the RF-1 Zone at premises 1350 Queen Street, N.E. (Square 4076W, Lots 57 and 58).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant within 200 feet of your property is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. You should have already received an official notice regarding the application's original hearing date per the Zoning Regulations of the District of Columbia. As a courtesy, this notice is provided to surrounding property owners with information about the rescheduled hearing date and information about listening and participating virtually.

PLEASE NOTE REGARDING THE HEARING SCHEDULE:

There is the possibility that cases may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled virtual hearing date noted above. The line-up of cases on the hearing agenda and any scheduling changes to the case will be posted to the BZA calendar the day before the hearing.

B. Sign up to provide testimony at the virtual hearing:

- Hard copies of documents will not be accepted at this time.

- Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the originally scheduled hearing date set forth in this letter.
