

The following Board of Zoning Adjustment (BZA) application has been rescheduled for the Virtual Public Hearing session on Wednesday, October 21, 2020 beginning at 9:30 a.m. See page two for more details about accessing and participating in the virtual hearing via Webex and telephone.

Application of Vitis Investments LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the residential conversion requirements of Subtitle U § 320.2, and pursuant to Subtitle X, Chapter 10, for variances from the residential conversion requirements of Subtitle U § 320.2(d), and from the limit on number of stories under Subtitle E § 303.1, to convert an existing detached principal dwelling unit to an 11-unit apartment house in the RF-1 Zone at premises 421 T Street, N.W. (Square 3090, Lots 804, 805, and 807).

### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant within 200 feet of your property is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
