Dear ANC Single Member District Commissioner:

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>April 22, 2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>October 28, 2020 at 9:30 am</u>, virtually via WebEx, concerning the following application:

Application of Brad Mueller, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 304.1 to construct a two-story accessory garage structure in the rear yard of an existing attached principal dwelling unit in the RF-1 Zone at premises 1309 Potomac Avenue, S.E. (Square 1046, Lot 854).
