An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>April 22, 2020</u> through the Interactive Zoning Information System (IZIS).

(Square 1046, Lot 854).
