Application of Foundation to Support Animal Protection, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exceptions under the lodging use requirements of Subtitle U § 504.1(f), to renovate the interior of the building to accommodate space for 10 guests in the existing office building in the MU-15 Zone at premises 1536 16th Street N.W. (Square 180, Lot 42).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

There is the possibility that cases may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled virtual hearing date noted above.
