## HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

#### A. Watch/listen to the hearing:

# **B.** Sign up to provide testimony at the virtual hearing:

- **C. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are **required to be sent at least 24 hours before the hearing**.

  - Hard copies of documents will not be accepted at this time.
