- the lot width requirements of Subtitle E § 201.1 (pursuant to Subtitle X, Chapter 10)
- the side yard requirements of Subtitle E § 207.2 (pursuant to Subtitle X, Chapter 10)
- the rear yard requirements of Subtitle E § 506.1 (pursuant to Subtitle X, Chapter 10)

Project: To subdivide the existing vacant lot, and to construct two new, three-story, principal dwelling units in the PDR-5/RF-3 Zone.

HOW TO PARTICIPATE IN THE CASE

Though ANC reports may be filed at any time prior to the Board’s final deliberation on the case, the ANC is strongly encouraged to submit their report no later than seven days prior to the public hearing date so that the Board has ample time to consider the ANC’s position.

HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

A. Watch/listen to the hearing:

- C. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are **required to be sent at least 24 hours before the hearing.**
- Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment or include the statement in the body of the email to bzasubmissions@dc.gov.
 - Hard copies of documents will not be accepted at this time.
