An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on December 18, 2020 through the Interactive Zoning Information System (IZIS).

Project: To construct a third-story addition on the top of the existing two-story portion of the building, and a three-story rear addition, and to convert the existing, detached, three-story principal dwelling unit into a three-unit residential building in the RF-1 Zone.

You will need to create a username and password if you have not done so already.

HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

C. Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are **required to be sent at least 24 hours before the hearing**.

- Hard copies of documents will not be accepted at this time.

The ANC may require the Applicant to appear at the next regularly scheduled ANC meeting to present their case.
