Dear Chairperson Hill and Members of the Board:

In support of the motion attached as <u>Exhibit A</u>, the Applicant requests the Board allow this letter and attached updated Transportation Management Plan ("**TMP**") (<u>Exhibit B</u>) into the record after the 21-day submission deadline under 11-Y DCMR §300.15.

In the District Department of Transportation ("**DDOT**") report dated October 18, 2021, DDOT requested that the Applicant compile all of the commitments regarding the transportation mitigation package into a single, stand-alone document. Wells & Associates, the Applicant's transportation consultant, prepared the requested document, which is attached as <u>Exhibit B</u>. The attached TMP does not include any new information. Rather, it compiles the River School's transportation commitments outlined in The River School Comprehensive Transportation Review (dated September 2021 and in the record at Exhibit 46A) and the subsequent addendum dated October 8, 2021 (included in DDOT's report in the record at Exhibit 69A). The compiled commitments also reflect amendments based on DDOT's proposed conditions outlined in their October 18, 2021 report.
