On behalf of KAJ VENTURES LLC (the "Applicant"), the Applicant filed its Prehearing Submission on June 30, 2021 (Ex. 35-36A), which specifically stated the Applicant's intent to remove its prior request for special exception relief pursuant to 11-C DCMR § 605.1 for a partial reduction in the Green Area Ratio ("GAR") requirements of 11-H DCMR § 910.1.

On July 1, 2021, the Office of Zoning ("OZ") requested that the Applicant file a revised Self-Certification form to reflect the Applicant's intent to remove its request for GAR relief. The Applicant filed the revised Self-Certification form on July 1, 2021 (Ex. 38). However, because the revised Self-Certification form was filed 20 days prior to the public hearing (not the 21 days required by 11-Y DCMR § 300.15), the Applicant respectfully requests a waiver pursuant to 11-Y DCMR § 101.9 from the requirement of 11-Y DCMR § 300.15 for the Board to accept the revised Self-Certification form 20 days prior to the public hearing. There is good cause to grant the waiver because it clarifies the zoning relief requested, and doing so will not prejudice the rights of any party.
